Requirements & Responsibilities: Initial_____

- Responsibility- Application for ABKC Club/Kennel is received within **60 days** no less than **30 days** (calendar days) prior to your show.
- Responsibility-Email the results to results@abkcdogs.org to be posted on website. PDF is on "Events" page- ABKC event reporting form.
- **Responsibility- All show entry forms must be turned in within 10 days after your show by the show Host.**
- Responsibility- To contact the Judge(s) and/or Representative to go over the "Judge/Representative & Host Agreement" form-this form MUST be provided to the ABKC after the agreement is signed within 30 days of before your show.
- Responsibility- To provide sufficient staffing for the Ring Stewart & Show Entries. This is not ABKC's or your ABKC Representatives responsibility.
- Required- That you purchase insurance for each event you have and show proof to the ABKC within 30 days of your show.
- Required- that you as a host, supply a "Wicket" to measure all dogs prior to registration.
- Not adhering to the conditions in the manner specified will be cause for (1) year club (show) suspension.
- All shows need an ABKC rep at the show for at least 3 shows before club is an approved "Sanctioned Club".

Fees: Initial_____

- \$100.00- For ABKC Show(1)-\$50.00 any extra shows (2) same day. **(60 days before show)**
- \$50.00- Penalty if requirements & responsibilities are not met **(less than 60 days)**
- \$150.00 (maximum) - *ABKC Representative* *plus travel expense (due on day of show)
- \$200.00 (maximum) - *ABKC Certified Judge* *plus travel expense (due on day of show)
- \$100.00-Sanctioned Club registration fee(1 time yearly Club fee beginning of each year) no rep needed for sanctioned clubs.

Temporary Numbers: Initial_____

- Price for temporary #'s is \$10.00 each.
- Temporary #'s are for dogs that are not registered with the ABKC and would like to show their dog at your event.
- Temporary #'s expire once your event has been concluded.
- Instructions for the purchaser are on back of the temporary #'s.
- Temporary #'s are only good for the show they were purchased at and **CAN NOT** be used for any other show.
- The fee of \$20.00 will still apply when registering their dog with ABKC.
- Show winners will need to register their dog(s) within 10 days of the show date or the win will be voided.
- **These are to be used for your show date only!**
- All unused temporary #'s and payment must be mailed back to the address listed above.
- A Kennel/Club suspension of having any future ABKC Sanctioned Shows could occur if unused temporary #'s and payment are **not returned within 10 business days** from the date of your show.

NOTE: Please have the purchaser retain the small top stub of the temporary # for their record and mail the bottom portion back to ABKC with payment of \$20.00, front & inside of current pedigree with a completed registration form.
